THE ROMANIAN GOVERNMENT - MINISTRY OF PUBLIC FINANCE

If you do not receive the tax bill, you have the obligation to request it. **In case of refusal, you are entitled to benefit of the purchased goods or service provided without paying the counter value. Please request and keep the bills in order to participate at the monthly and occasional withdrawals of the bill lottery.** It is forbidden to hand over another document that is attesting the payment of the value of the goods or services provided, other than the bill. In order to signal the economic operators' failure to comply with the legal obligations, you can call, non-stop and free of charge, **the Ministry of Public Finance's TelVerde service: 0800.800.085** These rights and obligations are established by the provisions of the Emergency Government Ordinance no. 28/1999 regarding the obligation of the economic operators to have electronic fiscal cash registers in use.
